This position requires the level of knowledge and skills necessary to diagnose and repair emergency vehicles, small engines and equipment. Potential employees applying for this job will have their backgrounds checked, including criminal and employment history. The Emergency Vehicle Technician Assistant reports to the Fleet Director and will work a 40-hour workweek with occasional overtime including evenings and weekends to fulfill immediate needs

QUALIFICATIONS

- Must hold a valid Texas Driver's license and have an acceptable driving record.
- High School Diploma or GED.
- ASE or EVT, certification is required within the first year to remain in position

- Assist with diagnosing and accurately perform all phases of vehicle repairs
- Remove, clean, repair, reinstall, and adjust vehicle components
- Knowledge of driveline components
- Knowledge of electrical/electronic components
- Knowledge of brakes/suspension/steering/exhaust
- Ability to learn Various Scan tool operations
- Ensure work orders are properly completed
- Ensure safe use of power and hand-held tools
- Perform road calls and emergency services as necessary
- Communicate professionally with vendors, team members, and supervisors
